Reference is made to memo of SA THOMAS FITZ PATRICK dated 2/3/72.

Referenced memo instructed that pending cases be assigned for each military installation in Miss. in order to be aware of possible extremist activities.

These cases were reviewed by the Inspector during the recent inspection of the Jackson Office, and the Inspector concluded that these cases should not be kept in a pending status. Accordingly, these cases are now being closed.

However, recipients should insure that close liaison with the appropriate military authorities at all installations in the State of Miss. is maintained so that we will be advised in advance of the potential for extremist activities among military personnel.
