Reference is made to memorandum dated April 1, 1968, at Chicago, Illinois, title and caption as above.

On April 1, 1968, Officer Leon West, Human Relations Section, Chicago, Illinois Police Department, advised the Federal Bureau of Investigation (FBI) at Chicago, Illinois, that the regular meeting of the Chicago Board of Education scheduled for this afternoon has been postponed. The group known as Clergy for Quality and Equality in Education, which is more correctly known as the Clergy for Quality and Equality in Our Public Schools, numbering approximately 40, visited the office of the president of the Board of Education, Mr. Frank Whiston, 55 East Washington Boulevard, Chicago for a 20 minute conference.

Following the conference some of the group proceeded to the Chicago Loop Temple on Washington Boulevard and had a press conference in conjunction with the Co-ordinating Council of Community Organizations (CCCCO). The press was at this time advised of a mass rally to be held on April 16, 1968, to show opposition to the Superintendent of Schools in Chicago, Dr. Benjamin C. Willis. This rally will be sponsored by the Clergy for Quality and Equality in Our Public Schools and the CCCC.

At 1:30 P.M., on March 23, 1968, Lynwood Harris, Human Relations Section, Chicago, Illinois, Police Department, advised the Federal Bureau of Investigation that forty representatives of captioned group appeared at the Board of Education, Chicago, Illinois, at 1:45 P.M., on March 23, 1968. This group was attempting to get a voice in the Board of Education meeting, which was to be held at 2:00 P.M., on March 23, 1968. The group then plans to go to City Hall, Chicago, where they will hold a short prayer service. The group is protesting the school policies of Chicago School Superintendent Benjamin C. Willis, and asking for improvement in educational facilities for both Negroes and whites in Chicago. No incidents or arrests have occurred and no incidents are anticipated.

At 5:05 P.M., on March 23, 1968, Sergeant Sam Holan, Human Relations Section, Chicago, Illinois, Police Department, advised that about forty representatives of captioned group held a demonstration at the Board of Education and at City Hall, Chicago, from 1:45 P.M., to 3:45 P.M., on March 23, 1968. The group demonstrated for change in the policies of Chicago School Superintendent Benjamin C. Willis and called for improvement of educational facilities for everyone in the city of Chicago.

No incidents or arrests occurred during the demonstration which was peaceful and orderly.
