Narrative Description:

Exterior of building

North Elevation

The Olney Carnegie Library is an example of the Classical Revival style, much the preferred style for libraries at that time.

The building is constructed of buff colored brick trimmed in natural limestone. The 11"x 1½ " brick is not common in this area. Dealers tell us several brickmakers tried making this size but for some reason the size was discontinued.

The facade shows symmetrically balanced windows, a set of three on each side of the entryway. The windows are double hung, with a plain glass lower pane. The upper pane is a very pale lavender leaded glass in a geometric pattern. The contiguous windows are separated by wooden mullions. Sills are limestone and the stone lintels feature a center keystone design with half-keystones at each end.

Six simple brick pilasters sit on a stone belt course which begins about one-fourth way up the building. The columns have Corinthian style capitals. A wooden entablature rests horizontally upon these columns. Two short brick pilasters support the two very large terra cotta finials on the roof. The roof has a very low slope. A short flight of steps leads up to a small open porch and to the main entrance. Limestone posts support the wrought iron bannisters. Just inside the entrance another flight of stairs leads up from the tiled entryway to the main floor, and another short flight leads down to the lower level.

East Elevation

The stone belt course mentioned in the north elevation continues around the building. Two sets of three windows each are separated by a bricked space which allows for a fireplace found on the inside wall. The back, or south section, is slightly narrower than the front section and has two windows, both double hung.

South Elevation

This elevation has four double-hung windows, separated from each other. At this elevation a small, approximately 4' x 4' entry way has been added at some unknown time, thus allowing for more efficient access and use of the service which it serves.

West Elevation

This elevation matches the East elevation with perhaps one exception. On this elevation a metal stairs has been added to serve as a fire escape.

Interior, Main level

Floors in this room are of black and white very small tiles. Plastered walls retain the original rosy brick color. Very narrow half-round moldings finished in gold leaf surround the room.

Two small fireplaces, located on east and west walls are featured. The fireplaces have narrow wooden mantels and small iron grates which were probably for coal. The fireplaces are finished in two by four inch red tile.

Baseboards and inside windows are very wide. Egg and dart plaster molding adorn the walls and the four ceiling beams.

Most spectacular in this main area is the 12 ft by 12 ft stained glass dome. Twenty-four Fleur-de-lis designs in various shades of blue and green border the bottom of the dome. The dome peaks to a four foot by four foot area with a center flower medallion. The dome is in excellent condition, partly because it has been covered with another roof to prevent leakage and damage from hail and storms.

Since the dome was covered over with a roof, artificial lighting has been added and the stained glass remains attractive. The roof and dome area is supported by four large round wooden ionic columns sitting on square bases thirty-six inches tall.

The main floor contains five rooms. This included two rest rooms, an office, the main room, and another room in the Southwest, and which is under the mezzanine. The mezzanine had been added in 1960-61.

THE LOWER LEVEL

The lower level is carpeted, this was also done in 1960-61, and oak shelving for books added to each wall. This level has one main room, two rest rooms, a service entry hallway, a furnace room, and a reading room. This reading room was completed ca. 1984. Prior to that time the space had been a coal bin. The basic change was closing a doorway between furnace and the coal bin, and creating an opening in another wall to connect to the main room. This will also be mentioned under alterations.

ALTERATIONS

The alterations have been minimal and were made to meet safety codes, increase capacity, or to protect the building and its contents:

1. Roofing over the dome to protect from leakage and damage. Date unknown but believed to be prior to 1950.
2. Addition of a small entryway at back of building. Improves servicing and acts as a fire escape. Date unknown but probably in 1960-61 when other changes were made in the lower level.
3. Fire escape added to west side of building, serves the main level. Date unknown but probably made to meet a safety requirement.
4. Addition of the mezzanine, 1960-1961. A partial wall was added to support the mezzanine floor, otherwise no significant change in structure. The addition did reduce the aesthetics on inside as some windows were partially blocked.
5. Coal bin converted to a reading room in 1984. Previously mentioned in describing the lower level. This made a very attractive reading room. Cost was approximately \$23,000, and partially reimbursed via a memorial to a business man and his wife.

Narrative Statement of Significance:

The Olney Carnegie Library is locally significant for Criterion A for education due to providing library services to the City of Olney and Criterion C for architecture as a local example of Classical Revival. The period of significance is from 1904 through 1951, the cutoff date for significance to the National Register of Historic Places. The Olney Public Library satisfies the requirements of the property type "Carnegie Library" as defined in the Multiple Property Documentation form, Illinois Carnegie Libraries.

Richland County was formed in 1841 from parts of Clay County on the west and Lawrence County on the east. Olney was named the county seat. In the early 1850's a citizen of Olney, and an attorney, developed additions to the city of Olney. He was also a director of the O & M Railroad and gave the railroad certain income or rights to some of his additions in return for the railroad coming through Olney. The first train passed through Olney in 1855. Later Olney was also served by north/south railroads. This, together with being near the center of the county, helped Olney to grow. The population in 1900, just prior to the building of the Carnegie Library, was 4260. In the year 2000, 100 years later, the population was determined to be 8631.

Early efforts to have a library began in 1882 when a public meeting was held for that purpose. Twenty-four men subscribed to stock in the Olney Public Library Association.

People donated vacant rooms in their homes for library use and donated time in providing library service. Nevertheless, it was always a financial struggle and in 1886 the association donated all its assets to the city in response to the city's pledge to continue the library.

Soon after 1900, the city learned of a Carnegie Library being built in Centralia, and an effort was started to obtain a Carnegie Library for this community. The building was opened in January of 1904. It was reported in the *Olney Advocate* that Mr. Gaddis was the architect and B.L. Robards was the builder.

In the early years of the Carnegie Library the lower level was not needed for library services and was available as a meeting room for various ladies' organizations in the community. The Olney Carnegie Library continued serving the community as a library until 1990 when a new and larger library was built.

ARCHITECTURAL COMPARISONS WITH OTHER BUILDINGS IN OLNEY

The Carnegie Library is the only Classical Revival building in Olney. The Classical Revival style is discussed in the Multiple Property Document.
