DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Winthrop Building is located on an irregular tract of land bounded by Washington, Water, Devonshire Streets and Spring Lane. The narrow building shape resulted from the widening of Water and Washington Streets. It is 9 stories high, but due to the slope of the site down towards Devonshire Street, that end has a subbasement (now used as a subway entrance). The Devonshire end is one bay wide, the opposite Washington Street end has two bays, and the longitudinal curved Water Street facade has nine bays. The Spring Lane facade has 11 bays and is not dressed. The yellow brick and terra cotta building is organized in four primary sections: ground and display level, executive offices, multiple office section, and attic.

The ground level is comprised of steel piers with large glazed bays in between. The visual effect of a non-load bearing masonry wall system has been diminished by the addition of recent store fronts (begun in 1938). The Water Street entrance, located toward the Washington Street end, is of a monumental neo-classical design inspired by Beaux Arts tradition; the cool light-colored stone contrasts to the rich yellow and brown of the superstructure. The supporting piers are panelled and have elaborate, inventive fluted capitals supporting a continuous entablature which consists of a flat metal architrave and a shallow terra cotta classical cornice.

The 2 floor executive office level makes an abrupt transition: brick courses alternate with narrowly spaced terra cotta courses in a scroll pattern. This horizontal design is broken by pairs of windows in plain terra cotta surrounds that form bays. In the superstructure all windows are uniformly sized and double hung.

Paired windows

A second terra cotta cornice begins the four-story office section, which continues the paired window bay system. However, here, to emphasize verticality, the full length of the bays are enclosed in plain, rectilinear terra cotta surrounds. Within the surrounds indicating floor separations and window divisions are terra cotta panels which have restrained mouldings and roundels on the Water Street facade and elaborate Beaux Arts swag and foliate designs in high relief on the end. The exception are the lateral window pairs on the Water Street facade; along with plain brickwork at the corners, these unconnected bays create a frame for the central window bays.

The attic is separated by a narrow stringcourse of neo-classical design in terra cotta. The windows, aligned with the bays beneath, are separate (repeating the lower corner arrangements) and have terra cotta surrounds. A duplicate of the immediately lower stringcourse begins the cornice, which, however, is entirely of copper. Widely spaced brackets with alternative rosettes support the extreme projection of the cornice, which emphasizes the flat roof.

STATEMENT OF SIGNIFICANCE

The Winthrop Building was designed in 1894 by the firm of Blackall and Newton, who also were architects for several Boston theaters existing today (Colonial and Wilbur) and the Tremont Temple. Builders were the prominent Boston firm of Woodbury and Leighton. It was the first structure in Boston in which the skeleton system of steel construction was used, and was completely fireproof when built.

Noticeable departures from the type of building which had been the prototype in Boston for such a long time include the following. First, the building is essentially a steel structure which consists of a steel frame with brick and terra cotta as a filling or skin. Second, the supporting columns are made of four pieces of steel, the cross section of one of which is like the letter Z, all riveted to a center place. These columns extend through the walls and are joined rigidly by beams in each story, and are also connected by horizontal trusses on the floors and vertical trusses in the partitions. The result of this construction is that the whole structure is rigid and firm against wind pressure, live or dead loads, or jars from adjoining sites. Third, the interior partitions all consist of a light framework of steel channels, over which is stretched a network of expanded metal lathing. The framework is then plastered heavily on each side with cement and dry mortar, forming a solid partition 1 1/2 inches thick. The extreme narrowness of the building on the Devonshire Street end and the lightness of the first and second stories were unavoidable in planning a building of this description on so small a lot.

The name of the building changed in 1899 to acknowledge the location of Governor John Winthrop's last dwelling erected in 1644 on Washington Street, formerly Cornhill Street. To the rear, along Spring Lane, was the ancient Great Spring, a natural spring which attracted Winthrop's colony to the Boston peninsula. A plaque commemorating this spring was erected by the Bostonian Society in 1907 on the Winthrop Building, although it is now missing.

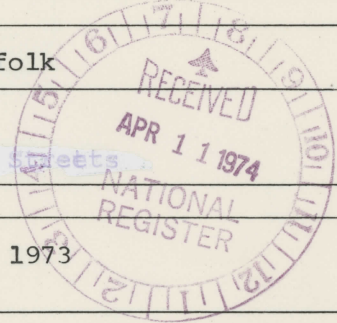

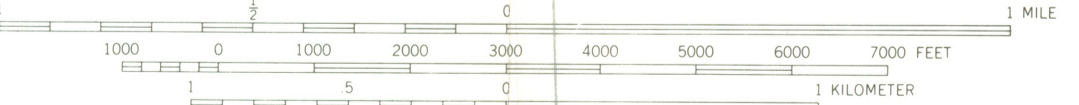
BOSTON SOUTH QUADRANGLE

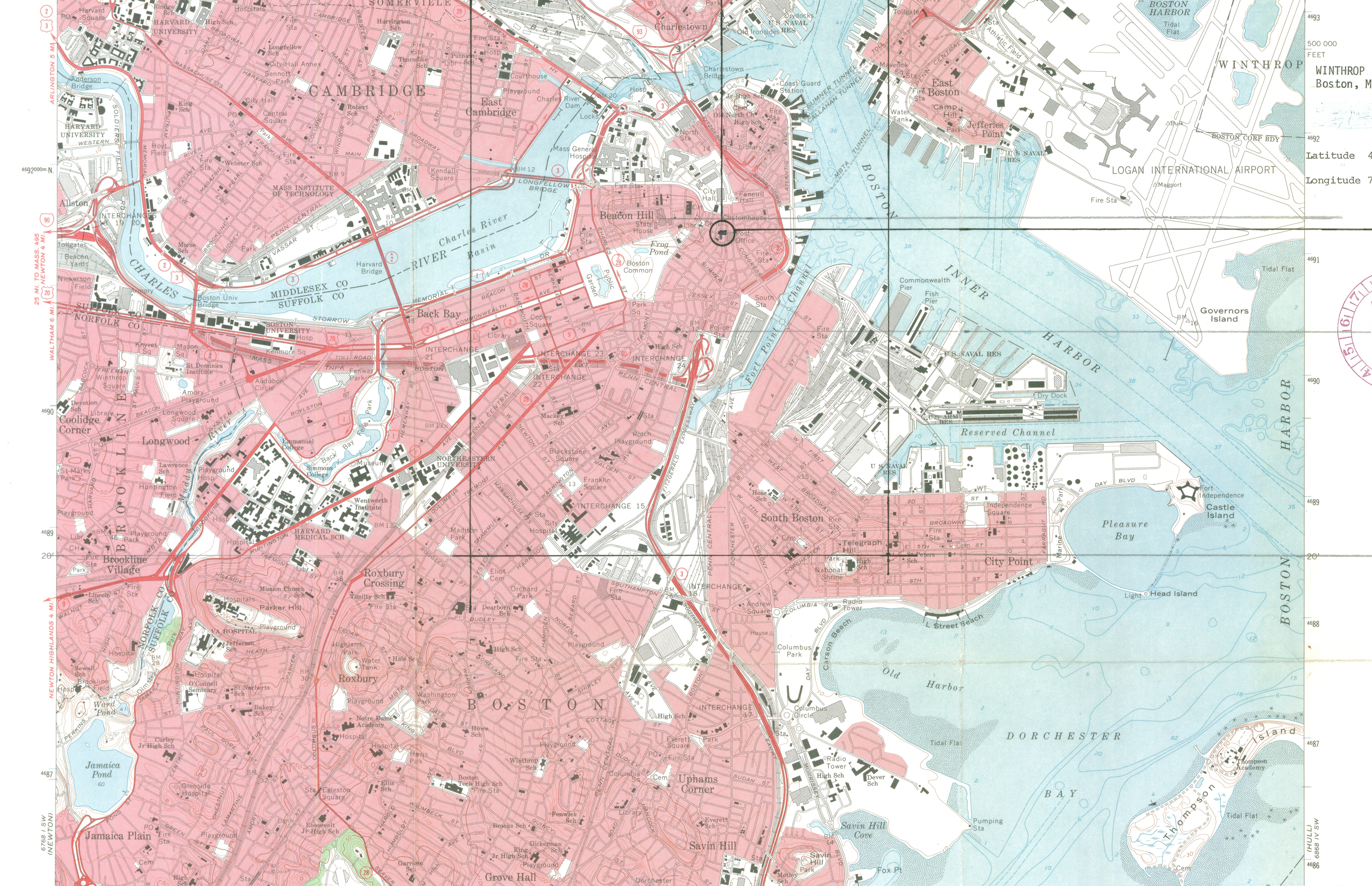

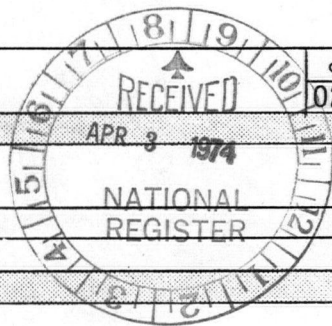
