Describe the present and original (if known) physical appearance

The Baxter Mill in Yarmouth is located on the north side of Route 28, one of the major thoroughfares of Cape Cod. It backs onto Mill Pond and is bordered by Mill Creek which runs under the road to the ocean. A low stone wall surrounds part of the area near the creek while an eight foot chain link fence surrounds the entire property.

The mill itself is 20' square and rises two stories to a low hip roof. It is sheathed with shingles and has plain white corner boards. Windows contain 15/15 sash and have white shutters formed of vertical boards. The main entry is located on the south elevation (pond side) and is reached by four steps. Two windows light this elevation. A second entry is located in the east elevation and two windows, one at each story are located to the right of it. The north elevation has two windows, one over the other slightly east of center. The west elevation has four evenly spaced windows, two at each story.

The grist mill built in this location in 1710 had an outside wheel. About 1860 the mill was rebuilt and an iron turbine was installed because the water level in Mill Pond was low and because winter freezing did a lot of damage to the outside wooden wheels. The old 1860 turbine (about four feet in diameter and five feet high) can be seen surrounded by carefully planted shrubs right on the edge of Route 28 at the mill's setting. An exact duplicate of that turbine was made and put inside the mill in 1961 by A. Harold Castongay during the mill's restoration. It is the only turbine-powered mill on Cape Cod (all others being wind mills or outside paddle wheels). Inside, the visible machinery shows how corn can be ground. The mill is in working order.

Statement of Significance (in one paragraph)

The Baxter Mill possesses integrity of location, design, materials and workmanship and is locally significant as the only remaining grist mill in Yarmouth and the only known turbine mill on Cape Cod. Constructed c. 1860 on the site of an early eighteenth century grist mill, it has played a continuous role in Yarmouth's developing economy and remains in use as a grist mill. The mill meets criterion A of the National Register of Historic Places.

The first mill on the site was constructed c. 1710 by John and Shubel Baxter with an outside waterwheel. The Baxters were a prominent local family and large landowners; Shubel served as a judge and representative as well as a miller. The mill was rebuilt (c. 1860) and modernized with an interior iron turbine. The mill remained in active use and under Baxter family ownership for another forty years when it stopped grinding corn.

In 1961 the mill was restored to its original use and donated to the town as a museum by A. Harold Castongay and George Kelley. Replicas of original tools were used in the restoration, including a new turbine which resembles the old one exactly and was made by the same company.

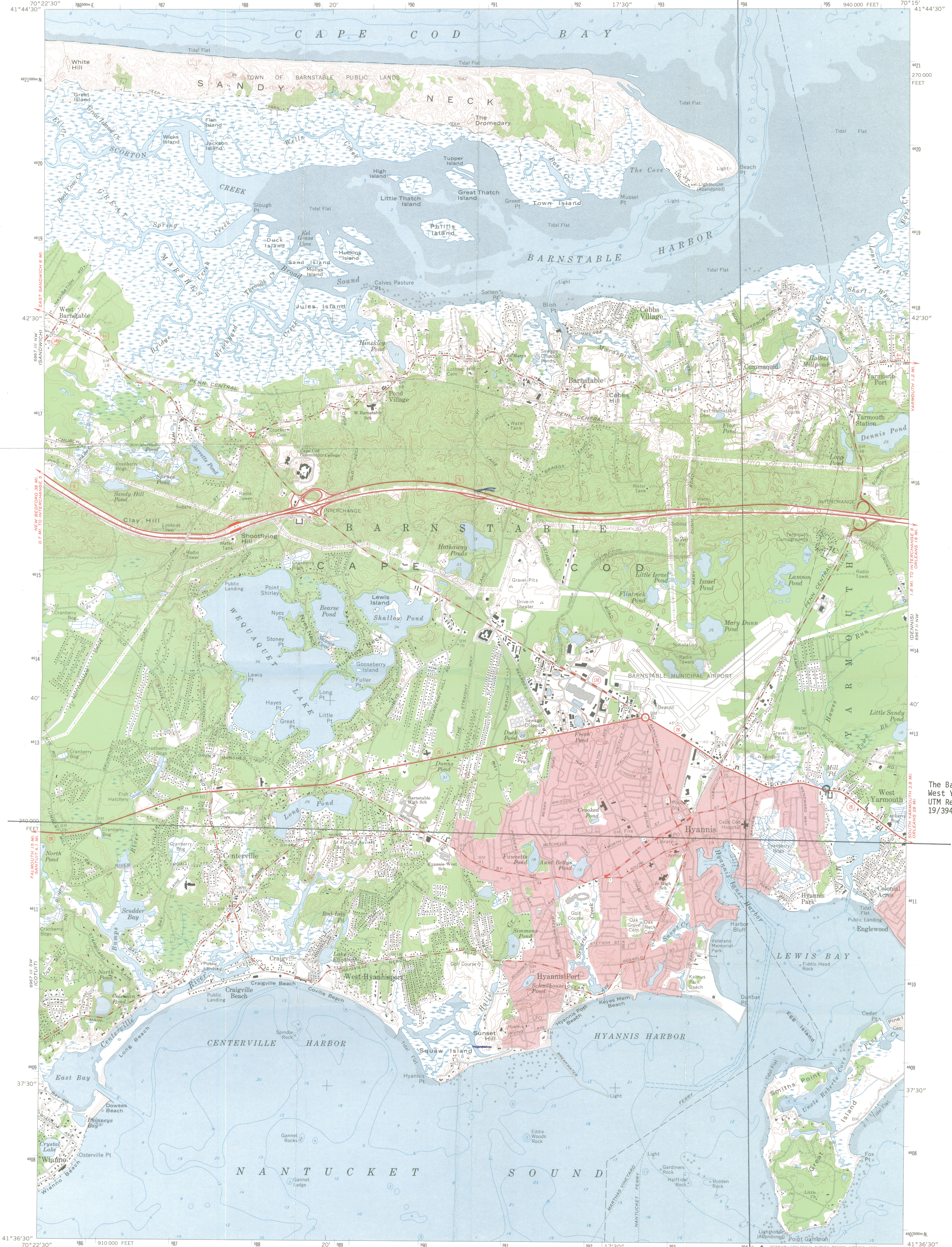

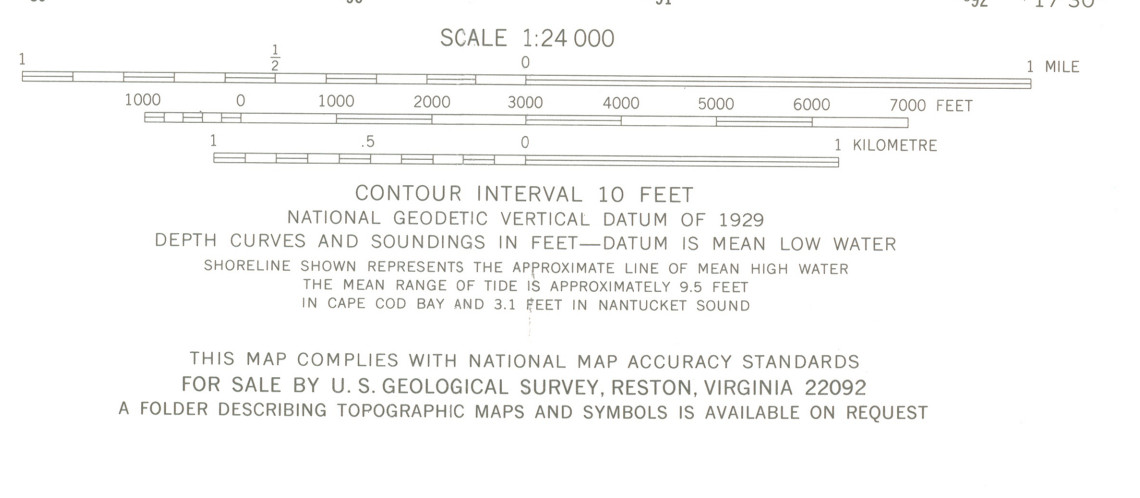
