Describe the present and original (if known) physical appearance

The Philemon Sage House sits isolated in a narrow valley on a triangular plot of forty acres south and west of the intersection of the Sandy Brook Road (Turnpike), now Marlborough Road, the Norfolk Road and the Rood Hill Road. This intersection, in the extreme southwest corner of the town of Sandisfield, is one mile south of the small village of South Sandisfield and one mile north of the Massachusetts/Connecticut border. The area is characterized by scattered 19th century farmhouses. The closest house on the Marlborough Road, a major thoroughfare since the early 19th century, is 1/4 mile away in either direction. Woods, marsh and a small amount of open meadow characterize the land immediately surrounding the house. The Sandy Brook crosses it from west to east, south of the house.

The front portion of the house facing the intersection (northeast) is 2 1/2 stories on a full rectangular cellar and was built c. 1827 as an addition to an earlier structure. Its simple, two story Federal period design is typical of the region. The house has a post and beam frame which is sheathed with clapboard on the exterior. Architectural detailing is simple and restrained. The center entry is marked by side lights under a plain architrave with light, projecting cornice. A similar narrow cornice and frieze at the roofline has returns at the end gables. This design scale is echoed in the facade's narrow corner boards. All 12/12 sash in the nine symmetrically placed windows on the front facade are original and contain a large percentage of "crown glass" panes. Both the north and south gable ends are identical, with six windows, four of 12/12 sash and two attic vent windows of 6/6 sash. Twin end chimneys are trimmed with a two brick corbel. Exterior shutters were added to the front and gable ends during the nineteenth century. The roof is presently asphalt shingle.

The interior retains many primary features. These include: boxed corner beams; all the original doors and hardware; and, on the first floor, single board wainscoting surmounted by a chairrail. Original mantels and parsons cupboard framing quarried marble fire boxes and hearths are preserved on the north chimney. The south chimney has been rebuilt and the mantels changed in.

The 1 1/2 story rear ell is the original part of the house built by Philemon Sage in 1799. In plan, it has three rooms around a central chimney which is offset to the rear of the ell. During or shortly after the 1827 expansion, these rooms were remodelled to serve as kitchen, pantry, battery, and an additional bedroom. A 1 1/2 story woodshed and privy attached to the west gable were probably built before 1827. Entry to the ell is through the south facade which is covered by a shed-roofed, shallow porch. A cheese cellar is accessed via a cellarway under the porch.

The foundation of one barn which once stood south of (behind) the house exists. Another barn or shed foundation is visible across the Norfolk Road. A tannery site is located on the Sandy Brook near the house.

Statement of Significance (in one paragraph)

The Philemon Sage House possesses integrity of location, design, setting, materials, workmanship and association. The 1827 building and concurrent renovation of an earlier (1799) section of the house together form a well preserved example of vernacular domestic architecture in the early part of the nineteenth century. The evolution of the house attests to the success of nineteenth century industrial and agricultural activities associated with it. Goods produced on the farm were traded both locally and regionally via the Sandy Brook Turnpike (now South Sandisfield and New Marlborough Roads). The Philemon Sage House thus meets criteria A and C of the National Register of Historic Places.

Sandisfield, formerly plantation "Number Three" granted by the Massachusetts General Court to a group of proprietors, became a town in 1762. Today, it is the most sparsely settled town in Berkshire County. South Sandisfield is one of three small villages in the town of Sandisfield which served as nuclei for settlement in the 18th century and later as a center for the local community.

Early settlers were attracted to South Sandisfield by land and the water resources of Sandy Brook. Stephen Sage, born 1752, the father of Philemon Sage, came to Sandisfield about 1770 and was one of the first settlers on Sandy Brook. Philemon Sage was born April 1, 1781. He married Betsy Chappel, born July 5, 1782, daughter of Richard and Grace Chappel of Sandisfield in 1799. He is known to have built the 1 1/2 story rear ell of the house as a home that same year on a portion of his father's land. It contained three rooms with a loft and central chimney.

Working with his father, Philemon developed a successful dairy business, producing cheese for sale and trade in the region. He also operated a small tannery behind the house on Sandy Brook. Through both ventures, he became quite affluent for a rural farmer. With the construction of the Sandy Brook Turnpike in 1803, Philemon Sage's house was located on a major trade and stage route for the Red-Bird line connecting Hartford and Albany. It became a county road in 1828.

In 1827 Philemon Sage's father deeded him the remainder of the farm, which included the land on which to build the 2 1/2 story Federal portion of the house facing the turnpike. This provided seven more rooms to house his growing family which would total eight children, Caius Marcus, Ann Eliza, David Douglass, Solomon Seth, Mary Celestia, Rufus Cable, Augustus Philemon and Joseph Chappel, all born between 1806 and 1823.

Records from a neighbor, Abner Webster's Sawmill Account book, show a great deal of business transacted between Philemon and Webster, up the Sandy Brook. Between 1831 and 1839, raw timber and tanned leather were traded for sawed lumber and cash. Philemon was appointed for a term as the first postmaster in South Sandisfield on April 29, 1844. The post office was run from the house at the four corners for about a year before it was discontinued in 1845, mostly for political reasons. Philemon Sage died at age 77 on August 9, 1858, and was buried in the South Sandisfield cemetery. The estate

was not probated until 1861 and contains an extensive inventory of real and personal property listing all the effects of a working farm and home. Household and farm goods were valued at \$1,157.62 and the 80 acre homestead farm at \$2,500. As a provision of his will, daughter, Ann Eliza and son, Augustus remained living in the house. Ann Eliza Sage died in 1896, the property being owned by the Sage family for over 97 years. Only two subsequent owners have occupied the house prior to preservation by Mr. and Mrs. Donald Dornon in 1952.

The remains of several barns, outbuildings and a tannery associated with the house, exist as tangible records of past agricultural and industrial activities. Their preservation indicates a good potential for the presence of less visible additional historic archaeological resources in the form of structural features and artifact concentrations. These may be located through archaeological investigation in and around the main house. Excavation of these materials could produce an assemblage of materials associated with 18th and 19th century domestic, farm, and industrial activities. Analysis of materials from the period of Philemon Sage's occupation would be useful in supplementing and comparison with the documentary evidence on this prosperous early 19th century farm.

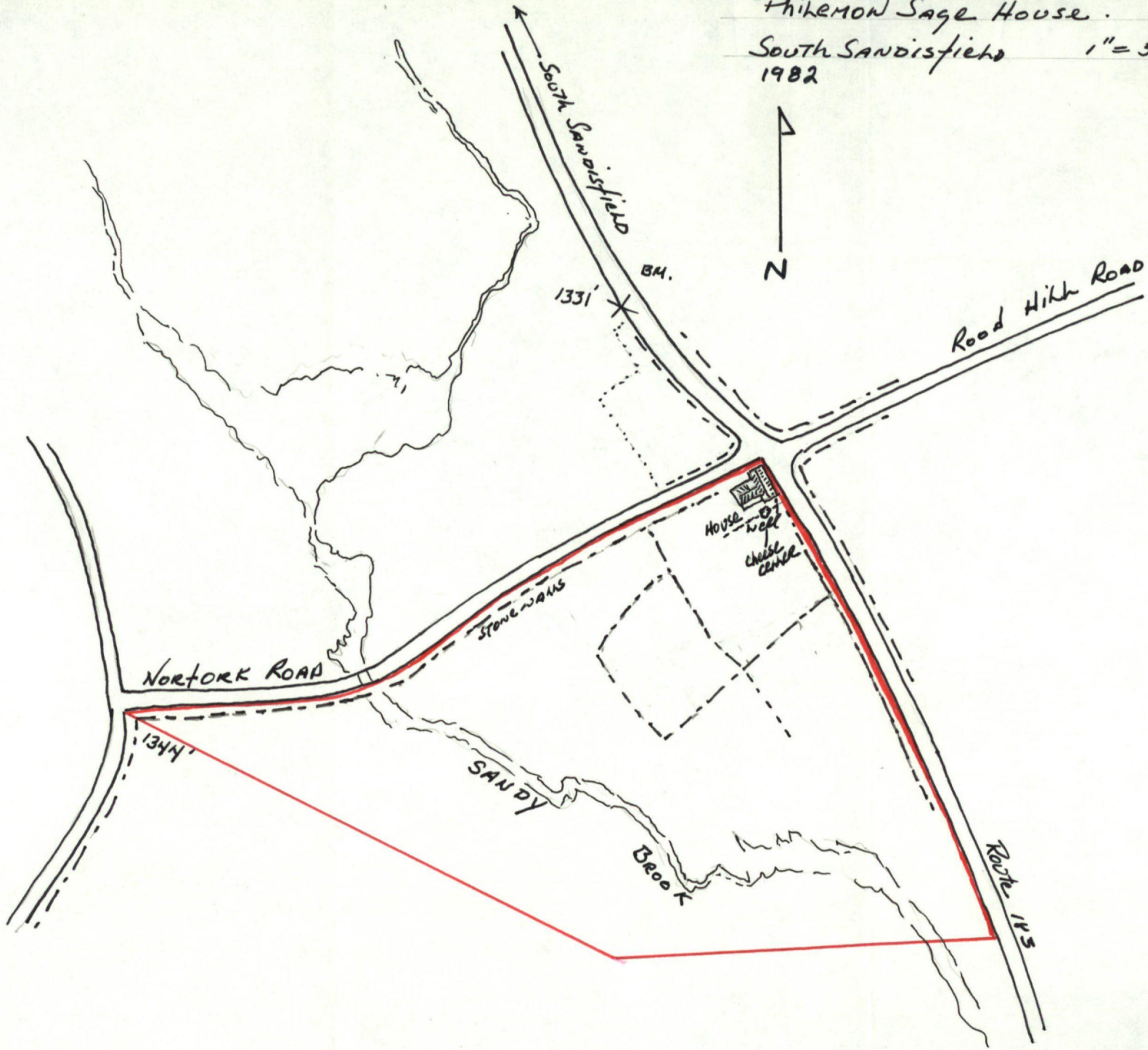

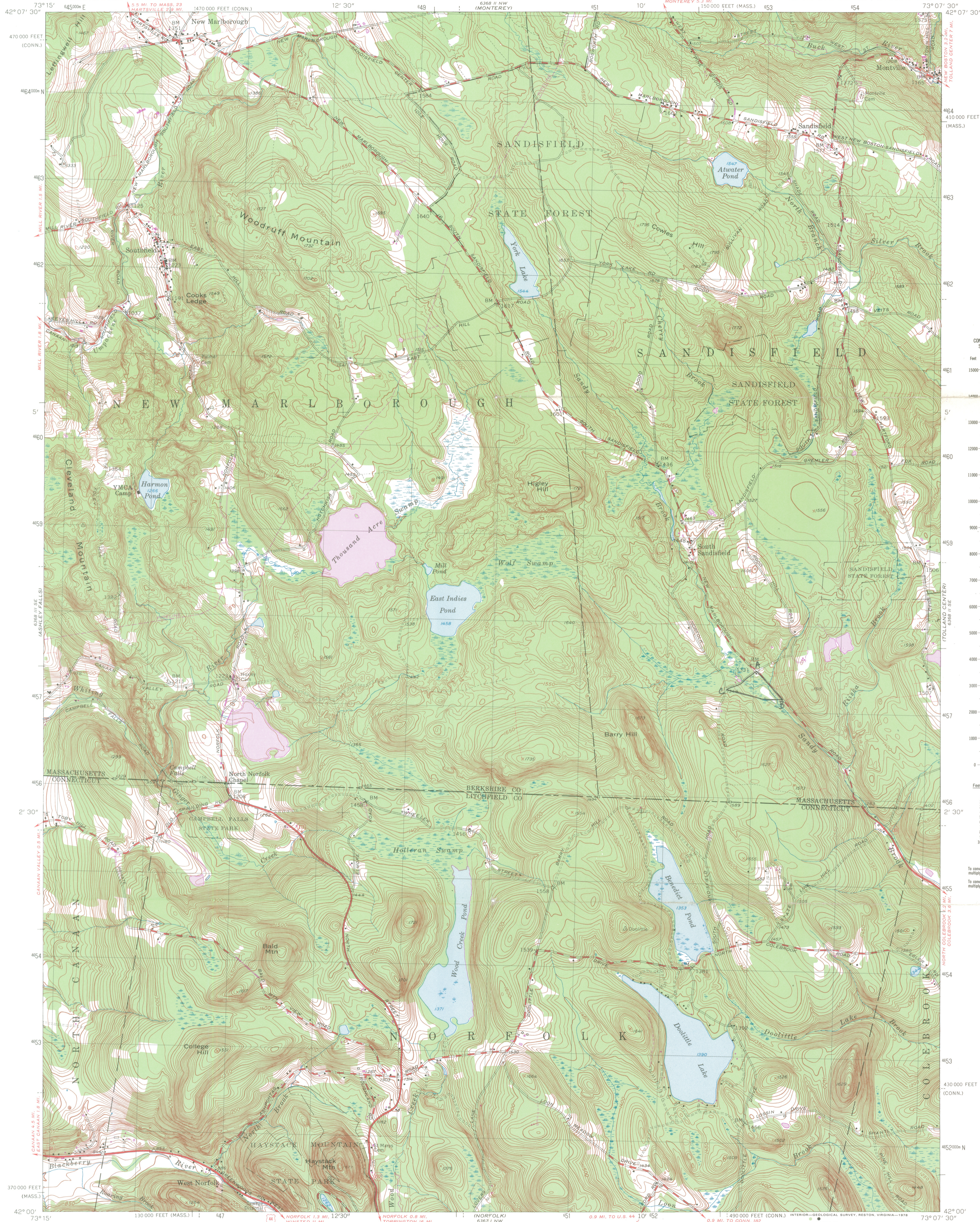

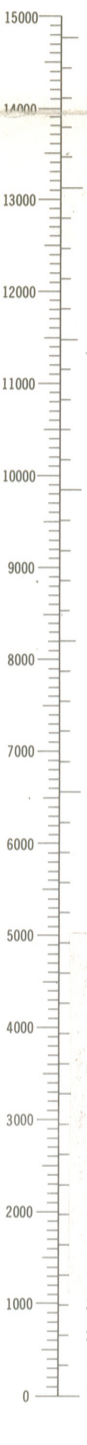
Philemon Sage House, view Southwest,

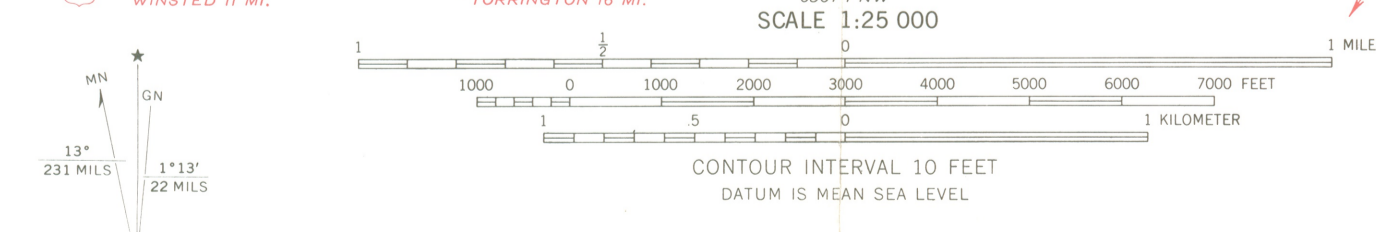
