Describe the present and original (if known) physical appearance

Camp Atwater is located in the small central Massachusetts town of North Brookfield on the shore of Lake Lashaway. It encompasses 67 acres of land on both sides of Shore Road; 50 acres remain undeveloped. Interior access is gained by a U-shaped road which extends south toward the lake. Atwater includes 325 feet of lakefront property with a retaining wall and beach. In addition, the camp owns a three acre island which once housed a camper hut. This was destroyed, but its stone fireplace remains.

Twenty-four buildings, most constructed between 1921 and 1945, stand on the camp grounds. The major buildings, such as the Main Lodge, Recreation Hall, and Dining Hall, are ranged about the access road while the fourteen campers' cabins surround them. Additionally, the camp grounds include such recreational facilities as basketball and tennis courts and baseball fields. Individual buildings are described below:

The Main Lodge (building #1; photo #1) is a two-story, rectangular plan building enclosed by a broad gable roof. It is surrounded by a partially enclosed verandah. Fenestration is irregular on all elevations, but windows generally contain multi-paned double hung sash.

The Recreation Hall (building #2; photo #2) is nearly identical to the Main Lodge. Its major feature is its broad gabled roof which extends out to form a one story porch.

The oldest structure on the camp grounds is the White Cottage (building #7; photo #5) which was built in 1760 by Roger Stevens. It is a traditional 2½ story, 5-bay, center hall house with twin rear wall chimneys. Its original design has been somewhat obscured by the addition of a c. 1870 one story porch to its facade. The porch's shed roof is supported on turned posts with decoratively sawn heads.

Another building which pre-dates the camp is the West Annex (building #9; photo #6). This is a simple two story structure with a gable end orientation. A one story porch with turned posts extends across the facade.

The campers' huts are similar in design and all are quite small and simple. The senior hut (building #11; photo #7,9) is representative. It is a one story, rectangular plan structure enclosed by a low ridge roof. It is sheathed with shiplap and stands on concrete pilings. Its summer use is visually reinforced by the porch attached to its facade, and the continuous band of windows set directly beneath the eaves.

Statement of Significance (in one paragraph)

Camp Atwater possesses integrity of location, design, setting, materials, and workmanship. It is distinguished as the first and only recognized camp for Blacks in the country and so meets criterion A. A number of its graduates have gone on to distinguish themselves in public life. so it also meets Criterion B.

Mary Atwater of Springfield donated 60 acres of land to Dr. William DeBerry in memory of her father, David Fisher Atwater, in 1921. During the first season in 1921, 40 Black children were enrolled at the camp and enjoyed many activities such as tennis, sailing, baseball, and basketball. The White Cottage (#7) accomodated these first campers and served as the center of camp activities. During the camp's second season, the Main Lodge was built and served a variety of needs. Other buildings have been constructed gradually as the camp grew in popularity.

In the early years, the majority of campers were from families of middle and upper class Blacks, but recently more disadvantaged youngsters have attended. In the beginning, campers were also drawn primarily from New England, but due to a rapid increase in popularity, campers were soon coming from all over the country. This includes many distinguished Black Americans who attribute much of their success to their stay at Camp Atwater and to the cultural and environmental exchanges and strong role models of leadership experienced there. Listed below are several of Camp Atwater's well known alumni:

Coleman Young - Mayor, Detroit, Michigan; Cliffton Wharton - Chancellor of the State University of New York State at Albany; William Harris - District Court Judge, Washington, D.C., and husband of Patricia Harris, Secretary of HEW; Rebecca Johnson - retired school principal, first Black principal in Springfield, MA; Late Daniel "Chappie" James - Four Star General, and the highest ranking Black in the U.S.; Bobby Thompson - Offensive Back for the Detroit Lions; Wade McRee - Solicitor General, U.S. Government; J. Tabor Bolden - Vice President, NBC, Washington, D.C.; Ronald B. Lee - former Postmaster General, and currently a Xerox Senior Vice President; Henry M. Thomas - youngest President of National Urban League.

The grounds of Camp Atwater should be considered to have the potential for the presence of pre-historic archaeological remains. Bordering Lake Lashaway, the camp is approximately one quarter mile north along the lake of the Drake Site, a large prehistoric site which has yielded diagnostic artifacts representative of the Archaic and Woodland periods. Camp Atwater is found in the same environmental setting as the Drake Site and therefore, may also have been a site of aboriginal occupation.

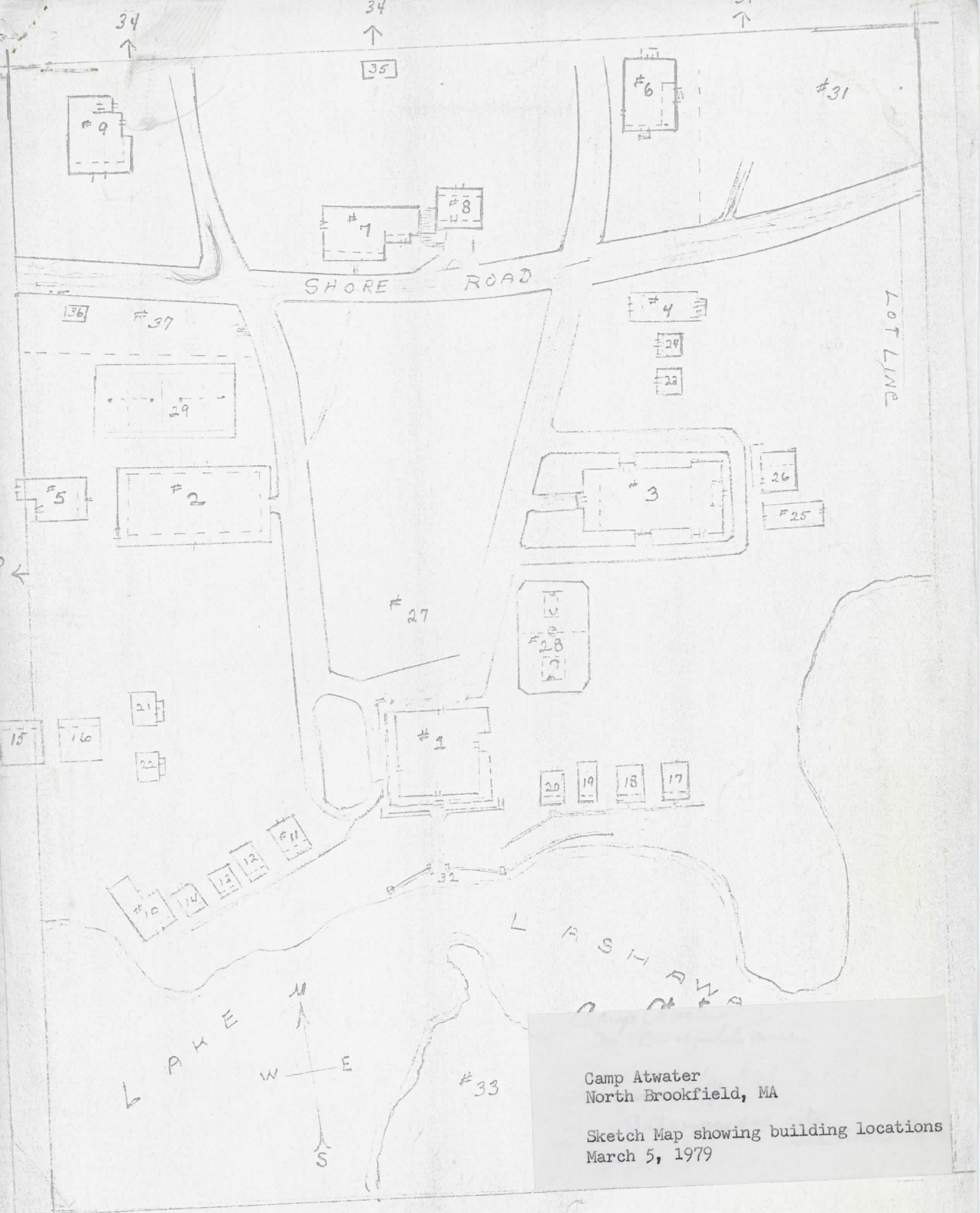

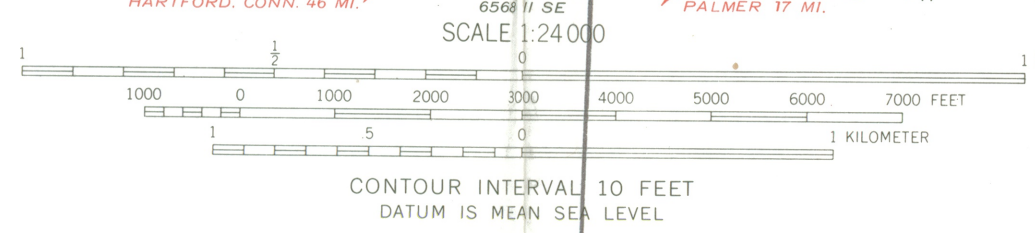
