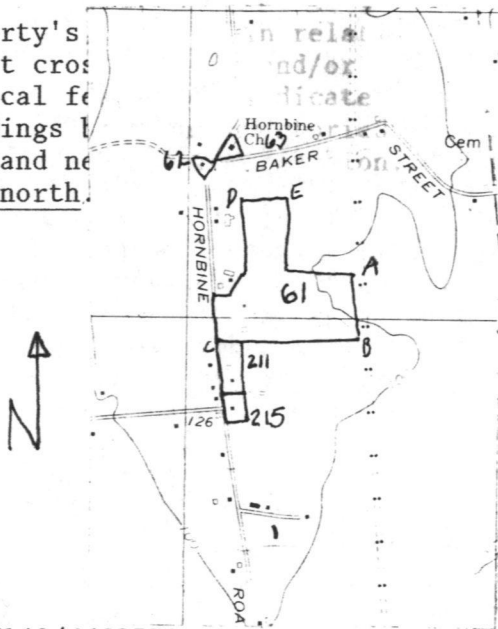

ARCHITECTURAL SIGNIFICANCE (Describe important architectural features and evaluate in terms of other buildings within the community.)

The Hornbine Baptist Church, a small one-story frame structure with a diminutive projecting hip roof porch with double entrances, is the earliest surviving Baptist meetinghouse in southeast Massachusetts. Originally, when erected in 1753, this building was a simple barn-like structure with a single large room. The entrance was in the bagle flank facing south onto Baker Street (stone step still in place) and the pulpit was on the north wall opposite. By 1802, the parish had grown, and increase in the congregation necessitated remodelling. A gallery was built at both ends of the room and pews were installed. The pulpit, made of hornbeam (presumably

The First Baptist Church in Massachusetts was established in Swansea, adjacent to Rehoboth, in 1663. It was a Six Principle Baptist Church under Rev. John Myles. In 1753, some thirty members withdrew from the second church in Swansea, Church of Christ and, with its blessing, organized what was to be known as the Hornbine Baptist Church in southeast Rehoboth. This was the third Baptist congregation in present-day Rehoboth. Daniel Martin was ordained as pastor with Mial Pearce as assistant. Initially, monthly meetings were held in the Mial Pearce House (#61) and occasionally at the Nathaniel Baker home on Baker Street. During the 18th and 19th centuries, the parish grew to such a large size that two major renovations were necessary to the original church of 1753 in 1802 and 1869. The parish has always been active in the community. Suppers are often held at the Church and clambakes have been an annual event since 1860 when the first clambake held in a nearby orchard, netted a thirty-cents profit. Since 1950, they have been held elsewhere in Rehoboth and serve one hundred-eighty to two hundred-fifty people. As champions of civic and religious freedom, the parishoners voted in 1888 to become non-denominational and rename the church as the First Free Baptist Church and Society of southeast Rehoboth, Massachusetts, Incorporated." This act by the Church encouraged participation in church-sponsored social activities by local residents belonging to other parishes. Consequently, the Hornbine Church has been instrumental in maintaining community life in Rehoboth and has many supportive ties outside the immediate, now small congregation.

Architectural Significance (Continued)

the origin of "Hornbine"), was enlarged with stairs on either side. This pulpit has since been cut down several tiems and is presently located in the southeast corner of the main floor. Further renovations in 1869 consisted of moving the entrance to its present location, lowering the ceiling, and erecting a raised alcove to serve as a pulpit. The chandelier and four bracket lamps, now electrified and still in use, were installed at this time. A social hall sixteen feet square added to the northwest corner that same year was enlarged by nineteen feet in 1874 and remodelled in the 1960s when a kitchen was installed. A four-stall horse shed and several storage sheds of the 1870s were removed in the mid 20th century. The potential for subsurface remains of these structures is undetermined.

Aside from modifications of the social hall and removal of late 19th century sheds, the Hornbine Church has not altered significantly since the 1870s, nor has its setting. It is located where Baker Street meets Hornbine, a minor intersection which is unmarred by any attempts to straighten or widen the roads. Another historically significant structure, the Hornbine School (#62) is directly across Hornbine Street.

Historical Significance (Continued)

As the earliest surviving Baptist Meetinghouse in southeast Massachusetts, well-maintained and still occupied by its original congregation, the Hornbine Baptist Church meets criteria A and C of the National Register of Historic Places individually.

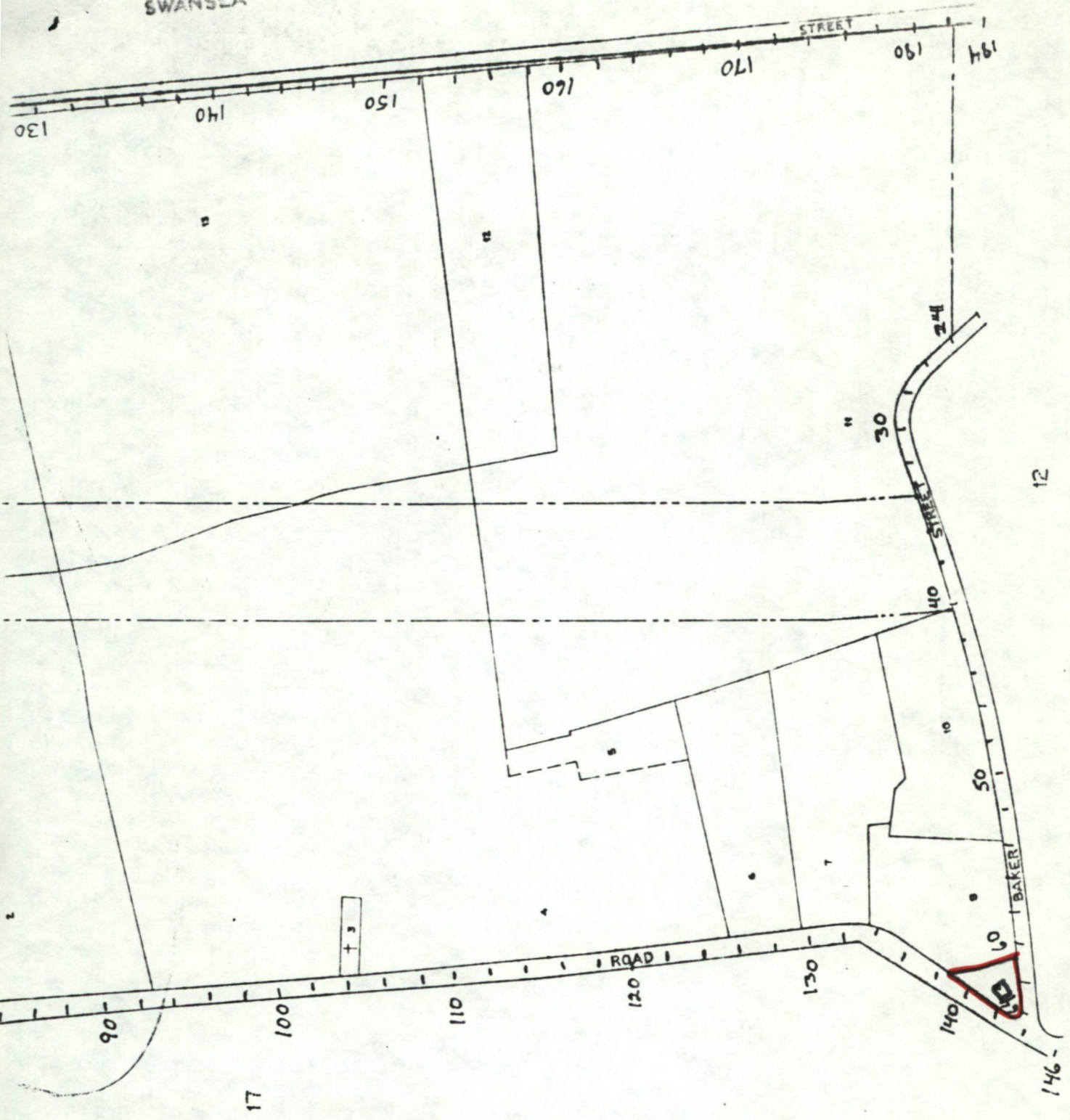
