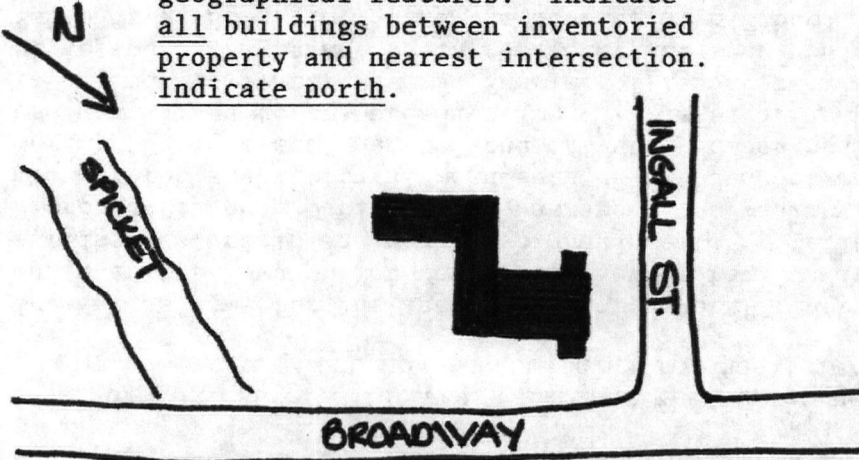

ARCHITECTURAL SIGNIFICANCE (Describe important architectural features and evaluate in terms of other buildings within the community.)

The 1906 Nevins Home for the Aged is a large 3-story complex of attached structures which are attributed to architect Henry Vaughn, and commissioned by Henry C. Nevins, the son of mill owner and philanthropist David Nevins. The brick and granite-trimmed main building is executed in the Jacobethan style which Vaughn favored. Of particular significance are the prominent parapets of the pitched roof. The parapets are trimmed with terra cotta crockets and the multi-paned windows are granite-trimmed. Prominent chimney masses are incorporated into end walls and granite-trimmed; a crenellated tower at the rear of the main building is partially visible at the front facade. The sprawling building occupies a wooded site along the Spicket River.

HISTORICAL SIGNIFICANCE (Explain the role owners played in local or state history and how the building relates to the development of the community.)

The Nevins Home for the Aged is one of several important public buildings donated to or built in the Town of Methuen by the Nevins family. It possesses integrity of location, design, setting, materials and workmanship and meets criteria B and C of the National Register of Historic Places. David Nevins was among the wealthy "triumverate" who were responsible for many of the architectural monuments of Methuen between 1883 and 1910. The widow of Henry Nevins (David's son) donated the privately-owned building for use as a Home for the Aged, a use maintained to the present time. It is significant as one of the last elaborate projects to be endowed by the Nevins, Searles or Tenney family and is representative of the style and extravagance which characterized such buildings as the Nevins Library (1883), Serlo Organ Hall (1897) and the Searles High School (1904).
