ARCHITECTURAL SIGNIFICANCE (Describe important architectural features and evaluate in terms of other buildings within the community.)

This is the grandest of the remaining Italianate houses in the area. Its heavy double brackets, dentil courses, and boldly molded window surrounds are details that mark a well-executed Italianate house. A fine polygonal bay, its flat roof supported by paired brackets, extends from the building's side. The building has a high Italianate balcony and porch that may have been added or altered slightly at a later period. The single-story porch, which wraps around the front and side of the building, is ornately decorated with brackets, dentils, paired columns, and turned spindles.

HISTORICAL SIGNIFICANCE (Explain the role owners played in local or state history and how the building relates to the development of the community.)

The Maria Bassett House, built ca. 1850, is one of earliest houses in a section of Arlington — the northwest corner — that did not fully develop until the 1920s and 1930s. The gentle hills overlooking the Mystic Lakes were known in the second half of the 19th century for dairy farming and this house, sited on a hill above the lakes, may have been associated with this endeavor.

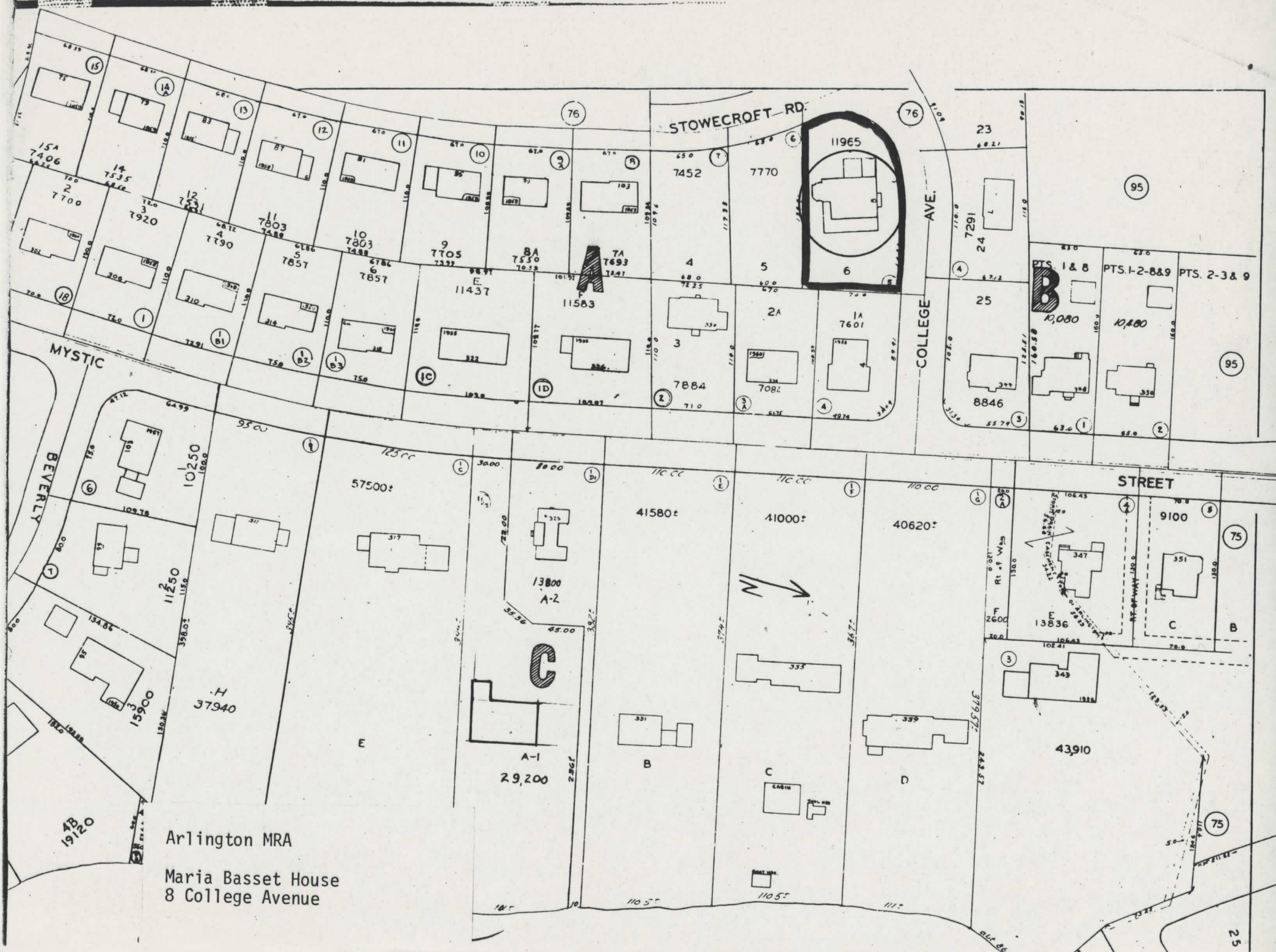
