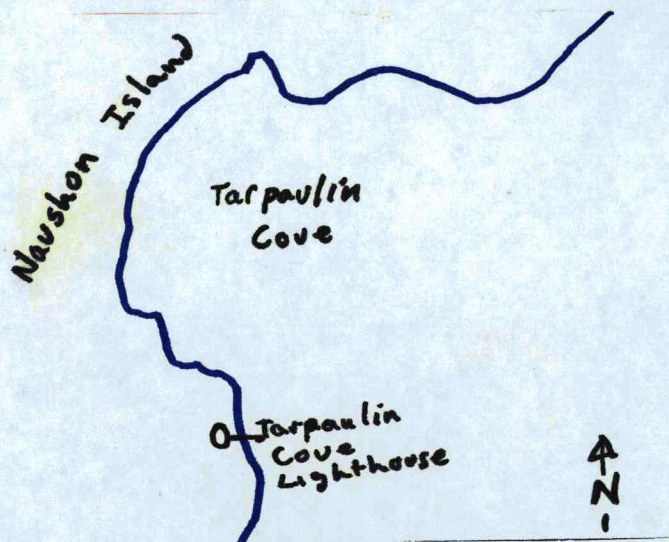

Tarpaulin Cove Light, Gosnold (Naushon Island)

SITE DESCRIPTION: The light stands on the west side of Tarpaulin Cove on the southwesterly shore of Naushon Island. This is the largest of the Elizabeth Islands, which are situated between Buzzard's Bay and Vineyard Sound, several miles off the southeasterly coast of Massachusetts. The Light is situated on a rise 45-50 feet above a boulder and sand beach in a meadow covered with grass and low scrub growth. A marker on the site states "This cove was widely used in sailing days as a shelter during storm or while awaiting favorable winds. Pirates used it in the 17th century as a base to prey on shipping in the Sound . . . a small village was located here in early days."

MAJOR ELEMENTS DESCRIPTION: The only extant element is a 78' cylindrical white brick tower (1856) with entry house. Signs of the foundations of the Keeper's House can still be identified.

Lens Room - Octagonal lens room with intact ventilator ball and lightning rod; balcony rail post with knobs, nine balusters set within rails in each sections; ventilator slit has ornamental iron frame. Metal Staircase (sandblasted) with wooden banister rail. The wooden walls of the Lamp Room were removed and the brick repointed, Summer 1981.

CHRONOLOGICAL HISTORY:

- 6/20/1816 - Land ceded from Commonwealth of Massachusetts;
- 11/14/1817 - additional land purchased for \$216;
- 1817 - light first manned;
- 1856 - the white brick light tower, 38' high, 19' diameter, was constructed on a concrete foundation. The cost was \$10,000;
- 1890 - Keeper's Dwelling (2 story, wood frame, 25' X 26" with 11' X 16" wing; 1500 square feet; basement), was built for \$3000;
- 1891 - tower remodeled;
- 1938 - hurricane destroyed fog bell and it was discontinued;
- 1951 - tower cleaned, painted, and whitewashed;
- 1958 - candlepower reduced from 4500 to 700;
- 1/6/1962 - Keepers Dwelling and other buildings (?) had deteriorated to "state of collapse" and were demolished.
- 1967 - Fourth Order lens, cut glass, (Fresnel type) installed;
- 1981 - LIGHT CHARACTERISTICS: CG 181 flashing 12vDC, Lampchanger CG6P-12v=6P Lamp 12c-2.03A, 375 mm glass lens.

#### LEVEL OF SIGNIFICANCE

Tarpaulin Cove Light possesses integrity of location, design, setting, materials and workmanship as well as associations with the development of aids to navigation in Massachusetts. Constructed in 1856, it is a good example of a mid-nineteenth century light and is one of the few historic structures on the island of Naushon. Overlooking a picturesque cove, it also possesses important scenic qualities. It meets criteria A and C of the NRHP on the state level as well as survey criteria 2a, 3a.

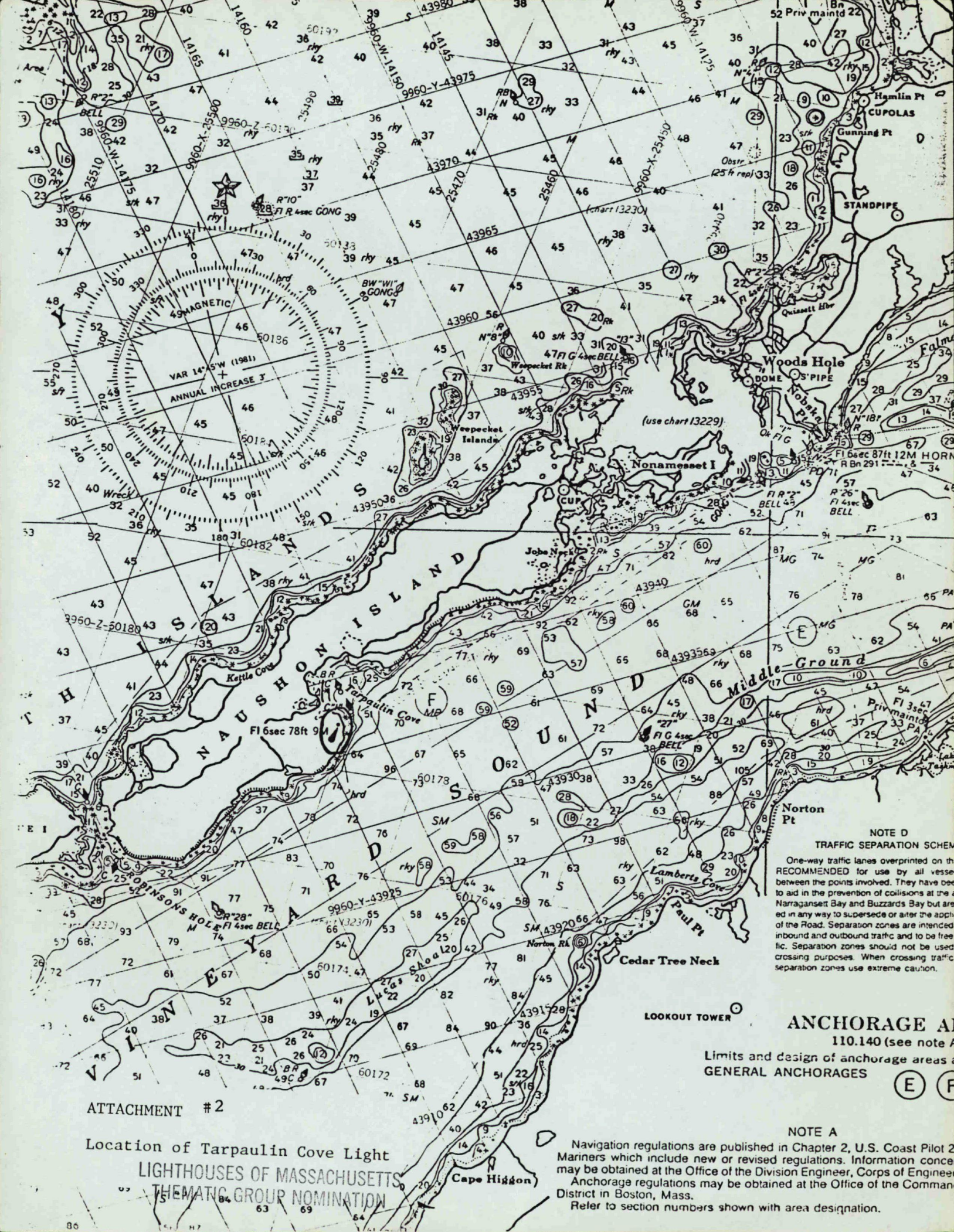

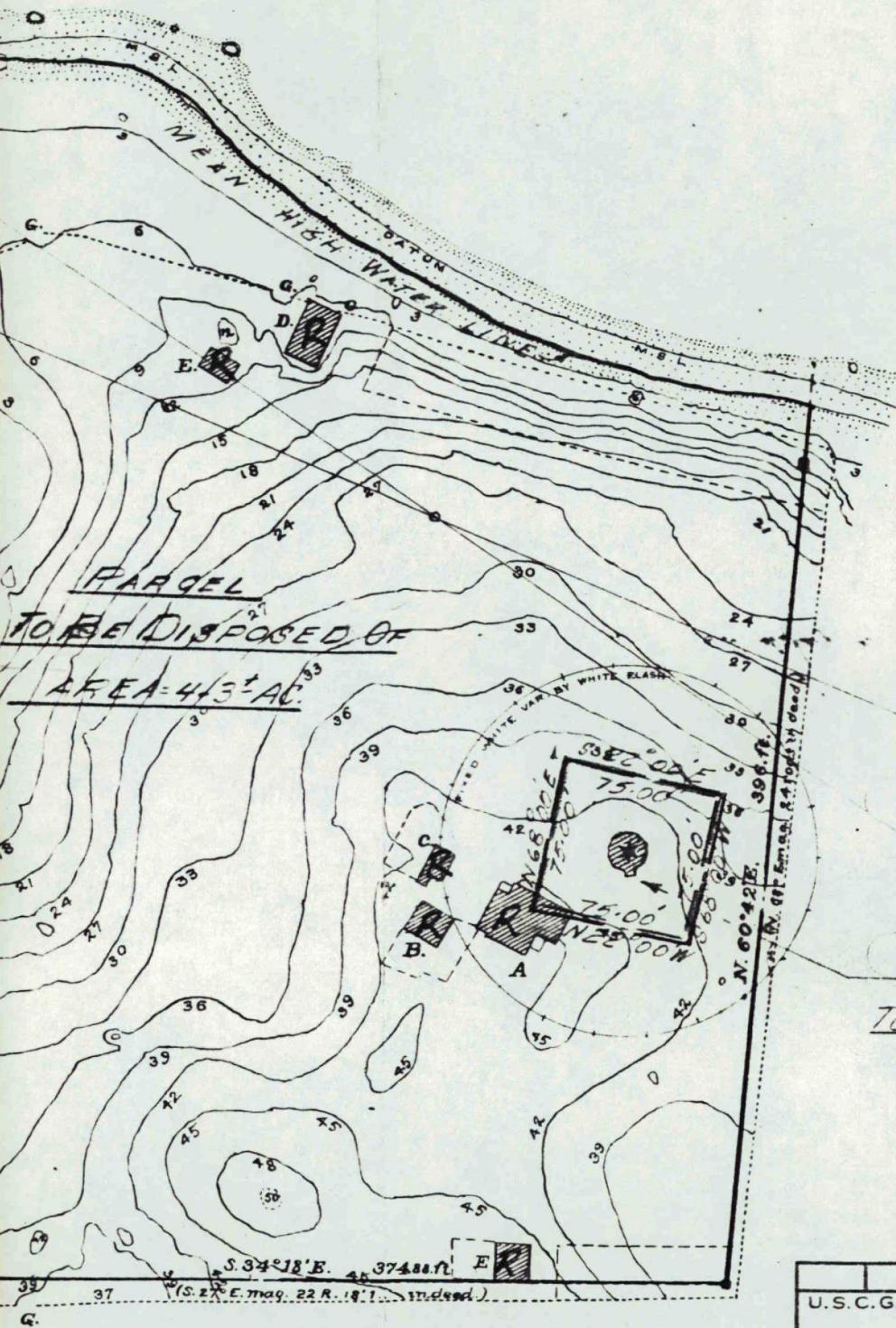
