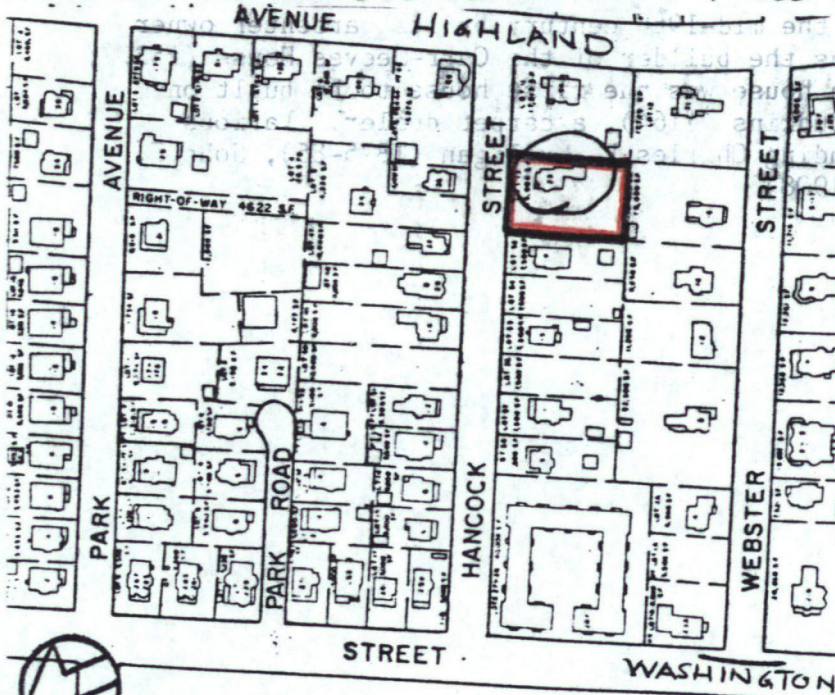

NATIONAL REGISTER CRITERIA STATEMENT (if applicable)

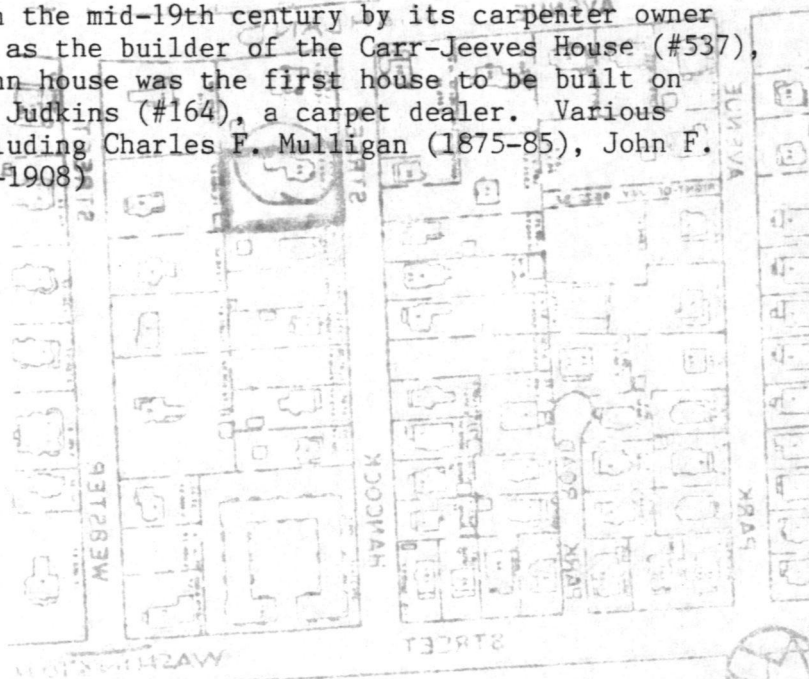
The J.H. Mann House possesses integrity of location, design, setting, materials, workmanship, feeling and associations. It is significant as an unusual picturesque cottage that combines elements of Italianate and Gothic Revival design, while reflecting the ideals of such mid-19th century pattern book writers as A.J. Downing. Built by its carpenter owner, it illustrates Winchester's fast growing popularity as a fashionable suburb. It meets criteria A and C of the National Register of Historic Places.

ARCHITECTURAL SIGNIFICANCE Describe important architectural features and evaluate in terms of other buildings within the community.

The Mann House is an unusual mid-19th century picturesque cottages displaying some features of the Gothic Revival style. It is a diminutive 1 1/2 story structure built on a T plan. The stem of the T projects forward from the facade and is surrmounted by tower with jerkin-headed roof and vergeboards. The main body of the building is enclosed by a double gable roof whose form resembles a monitor; finials and vergeboards highlight the gable ends. The house is sheathed with clapboards and trimmed with wide cornerboards with a beaded edge, a water table and a frieze with modified dentils. A double leaf door with round arched glazing is located on the left side of the tower beneath a shed roofed porch. An oriel window with arched glazing is attached to the right elevation.

HISTORICAL SIGNIFICANCE Explain the role owners played in local or state history and how the building relates to the development of the community.

This picturesque cottage was constructed in the mid-19th century by its carpenter owner James Mann. Mann has also been identified as the builder of the Carr-Jeeves House (#537), another cottage of unusual design. The Mann house was the first house to be built on Hancock Street, on land owned by Jerome B. Judkins (#164), a carpet dealer. Various businessmen owned the house after Mann including Charles F. Mulligan (1875-85), John F. Olson (1886-96) and Thomas A. Choate (1898-1908).
