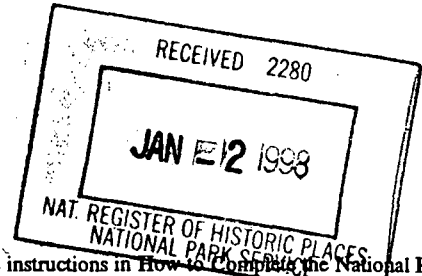

### Summary

The Alfred W. Greer House is a two-story, residential building constructed in 1915 in the Craftsman style. The dwelling is Poplar Bluff's most representative example of the Craftsman style and it retains much of its original design and detailing. With the exception of some enclosures of second floor and rear porch areas, the dwelling has not been significantly altered on the exterior or interior. The dwelling is of brick construction and features large brick porch piers on the main facade, a gable roof, one-over-one wood sash windows, and wide eaves with exposed rafters. The interior displays ornate woodwork on the first floor and has a particularly notable wood staircase. The original floor plan and the majority of interior detailing have retained throughout the dwelling. Included with the boundaries in a non-contributing garage.

### Narrative Description

The Alfred W. Greer House is located at 955 Kinzer Street in Poplar Bluff, Missouri. The dwelling is located on a residential street to the northwest of the downtown area. Constructed in 1915 as a single-family residence, the building's traditional residential use has continued without interruption to the present. The Alfred W. Greer House is a two-and-one-half-story, four-by-four-bay, Craftsman-style, rectangular-plan dwelling with a two-and-one-half-story side-gable wing. Constructed of brick laid in stretcher bond, building details include a first-floor cast concrete watertable, a low-pitched gable roof clad in clay tile, and wide, unenclosed eaves marked with paired, exposed, decorative roof rafters. Brick piers span the building's first and second floors and are located on all elevations. They are joined on the second floor by horizontal bands of recessed brick spandrels.

One-over-one double hung and single-light, fixed sash windows are located throughout the dwelling. First floor windows have been covered with metal security grilles. Paired, eight-light horizontal fixed windows are located within the half-story of the building's gable fields and are placed above frame window boxes supported by decorative purlins. At the base of the gable fields on the south, north, and east elevations are frame shed roof canopies covered in clay tile and supported by paired exposed rafters. Single-light, leaded, stained glass windows are located on the first floor of the west elevation and flank an exterior, end-wall chimney. The building's second chimney is located below the ridgeline on the north elevation.

The building's primary entrance on the south facade is composed of an original single-light glass and wood door. The entry is located beneath the dwelling's one-story entry porch on the main facade which has a corner brick piers and curved clay tile roof. The dwelling's porch has a brick railing, cast concrete floors, and two-story flanking columns joined on the second floor by a single, horizontal spandrel. A single-bay, side-gable porte-cochere roofed in clay tile adjoins the porch on the west facade. Cast concrete steps connect the porte-cochere and the porch. On the north facade of the dwelling the second story of the porch has original screened panels. On the east facade the second story porch has been enclosed with large fixed and one-over-one, aluminum sash windows. The first and second story porches on the rear (north) facade were also enclosed ca. 1950 with fixed and one-over-one aluminum sash windows.

Solid wood doors are located at the secondary entrances on the north (rear) elevation and lead to the first floor and basement. Over the first floor entrances is a ca. 1950 metal awning. Frame vertical boards enclose the space between the basement brick piers on the rear facade.

On the interior, the dwelling retains its original hardwood floors, plaster walls, beamed/coffered ceilings, and paneled wainscoting. The first floor has a central staircase, large parlor, living room, dining room, and kitchen. The original, built-in cabinetry with leaded and frosted glass remains in the dining room and kitchen. The dwelling's primary entrance opens onto a modest vestibule whose

detailing consists of plaster walls and a rectangular window containing leaded, lancet-shaped panes of clear glass. An original oak colonnade with square Doric motif columns separates the living room and dining room. Original paired cabinets with leaded glass doors flank the living room fireplace. The fireplace has a brick and stucco surround and above is a bracketed wood mantle.

One of the most notable features of the interior is the central staircase. This staircase has a central landing which is reached by three different runs of stairs. The landing is framed by square Doric motif wood columns with paneled wainscoting and vertical slat grilles. On the parlor side of the staircase is a built-in wood bench. On the second floor are a series of bedrooms which retain their original hardwood floors, plaster walls, and plaster ceilings. The bathrooms on this floor were remodeled in recent decades.

The Alfred W. Greer House rests on a gently sloping grassed lot on the north side of Kinzer Street. The lot is framed by cast concrete sidewalks and a cast concrete retaining wall. A flight of cast concrete steps with a wrought iron railing is located on the lot's southeast corner and connects with the sidewalk. A cast concrete driveway leads from the street through the porte-cochere and connects with a ca. 1925 brick, rectangular-plan garage. This garage has an exterior of brick and stucco and retains an original wood paneled garage bay, overhead track door. The garage has a gable roof of asphalt shingles and at the eavesd are exposed brackets. The garage is included as a non-contributing building to the property.

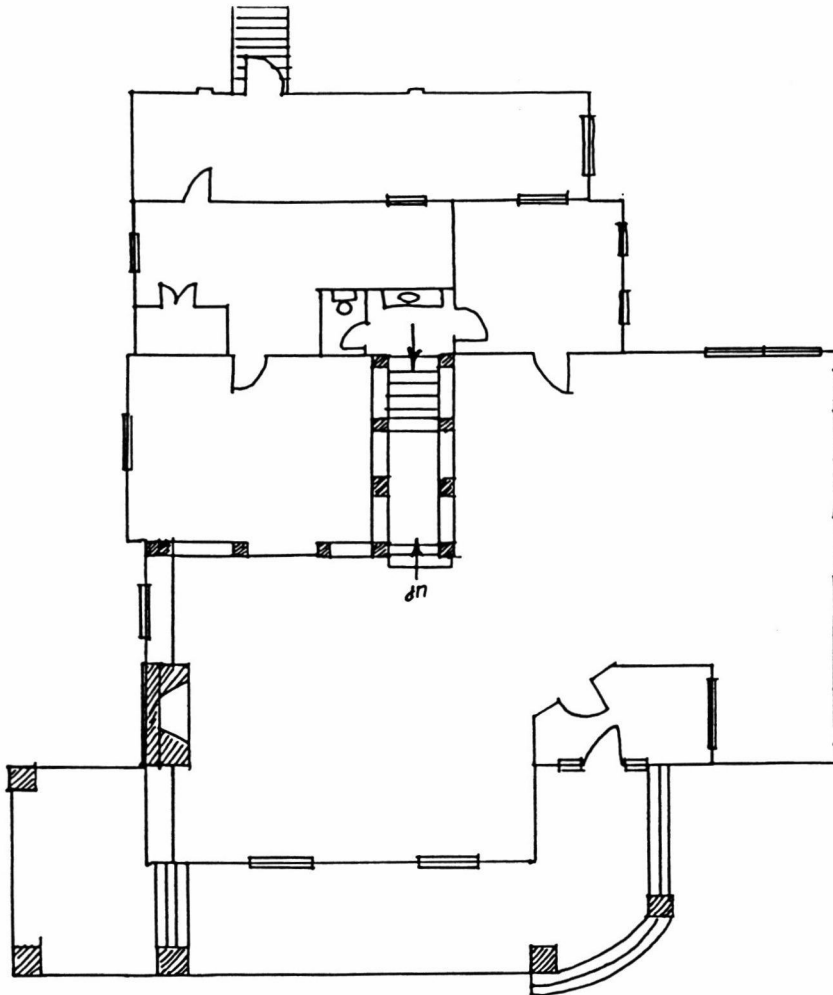

Not To Scale

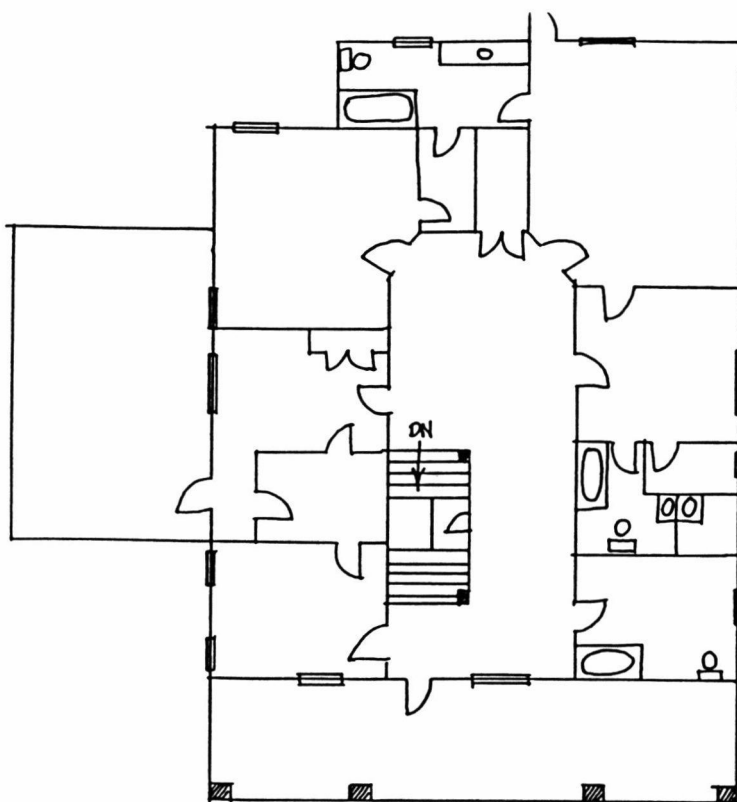

### SUMMARY

The Alfred W. Greer House is significant under National Register Criterion C for its architectural design. The dwelling is Poplar Bluff's finest example of the Craftsman style from the early 20th century, and its period of significance is its construction date of 1915. The dwelling was designed of brick, wood, and concrete, and retains its original clay tile roof. The dwelling's large porch spaces, horizontal appearance, and wide eaves are reflective of the Craftsman style. The interior of the dwelling also retains its original Craftsman style interior and features an elaborate central staircase, paneled wood wainscoting, wood colonnade, and built-in cabinets. With the exception of the glass enclosures of the porches on the east and rear facades, the Alfred W. Greer House has not been extensively altered and possesses integrity of its original design. The Alfred W. Greer House is associated with the historic context of Late 19th and Early 20th Century Residential Buildings of Poplar Bluff, Missouri, ca. 1880-1943. The dwelling is included within the Residential Buildings property type of the Historic Resources of Poplar Bluff, Missouri, multiple property nomination.

### HISTORICAL OVERVIEW

This dwelling has been owned by only two families since its construction. Alfred W. Greer (1874-1966) came to Poplar Bluff, Missouri from Kentucky in the late 19th century. Greer initially worked as a carpenter, but his business later grew to include contracting and lumber/building supply interests. Greer also came to own and operate the Greer Funeral Home (later the Greer-Croy-Fitch Funeral Home, currently Fitch-Hillis).<sup>1</sup>

Greer constructed his home at 955 Kinzer Street in 1915 and chose the Craftsman architectural style. As a lumberman, Greer utilized extensive amounts of oak and other hardwoods on the interior finishes of his house. Greer was also responsible for constructing three other homes located on the north side of Kinzer Street between his house and 10th Street. These dwellings are modest Bungalows of the period and do not possess notable architectural detailing. Additional homes constructed by Greer and his company are located throughout Poplar Bluff. The Greer family ownership of 955 Kinzer continued until 1922 when Alfred W. Greer sold the property to Joseph Sidney and Nellie Gray. Alfred W. Greer moved to another location in Poplar Bluff after the sale of the house and he died in 1966 at age 92.

Joseph and Nellie Gray moved to Poplar Bluff in January, 1914 where they established the J.S. Gray Wholesale Grocery Company. Gray was a member of the board of directors of the State Bank of Poplar Bluff and was active in the First Christian Church.<sup>2</sup> His wife, Nellie, was also active in civic affairs and was president of the Women's Community Government Club for 18 years. She also was active in organizing the Humane Society and served on the local board of the American Red Cross. They purchased this house in 1922 and at Joseph Gray's death on August 30, 1956, the property was inherited by his wife.<sup>3</sup> Upon Mrs. Gray's death on July 16, 1966, the Alfred W. Greer House was inherited by the Gray's daughter Pauline and her husband Frank Thompson Hearne. Mrs. Pauline Hearne continues to own and reside in the dwelling.
